## REC & ED 2021 Fall COVID 19 INFORMATION WAIVER & ACTIVITY PRE SCREENER

Rec & Ed follows the Ann Arbor Public School district's COVID-19 protocols, which are based on recommendations from the Centers for Disease Control, American Academy of Pediatrics, and the Washtenaw County Health Department. The protocols aim to reduce the risk of coronavirus transmission during Rec & Ed activities. AAPS Rec & Ed encourages participants ages 12+ to get vaccinated, as this is the most effective step that individuals can take to protect themselves and others

By initialing this waiver, I attest that I have read, understand, and agree that I (or any of my household members) will follow the requirements below. I understand that if these requirements are not followed, I and any of my household members may be suspended from future Rec & Ed activities. I further understand that the risk of contracting Covid-19 still exists even if all protocols are followed.

- 1. I agree to adhere to all COVID-19 safety protocols as currently required by the Ann Arbor Public Schools/Rec & Ed. These include:
  - Pre Screening before coming onto AAPS property (see below)
  - Maintaining appropriate physical distance from others while on school property
  - Wearing a mask at all times while within an AAPS facility (even for those individuals who are fully vaccinated)
- 2. I agree to stay home from class(es) if any of the following conditions occur:
  - Myself or a member of my household has tested positive for COVID-19, and is under isolation or quarantine orders by the local health department
  - Myself or a member of my household has COVID-19 symptoms
  - Myself or a member of my household has been tested for COVID-19 due to symptoms or exposure and is waiting for results
  - I have been in close contact (within 6 feet for more than 15 minutes) with someone who has a confirmed case of COVID-19
- 3. I agree that if I or any household member who was present at any Rec & Ed activity is diagnosed with COVID-19 during the same time frame as my class (es), I will contact the appropriate Rec & Ed staff member listed below:

## Screen Yourself Before Coming to any In-Person Rec

- 1. In the past 24 hours, have you experienced any of the following NEW or UNEXPECTED symptoms?
  - Fever of 100.4 or higher or feeling feverish (chills, sweating)
  - New cough
  - Difficulty breathing
  - Sore throat
  - Vomiting or diarrhea
  - New loss of taste or smell
  - New onset of severe headache, especially with a fever

If YES  $\rightarrow$  Stay home, contact your healthcare provider, consider seeking a COVID-19 test. **2. In the past week, has anyone in your household been diagnosed with COVID-19?** 

If YES  $\rightarrow$  You must quarantine from the date of last close contact with the infected individual. Contact appropriate Rec & Ed staff member

3. In the past week, have you been in close contact with anyone outside the home who has a confirmed or probable case of COVID-19?

If YES → You must quarantine from the date of last contact with the infected individual. Contact Rec & Ed the appropriate Rec & Ed staff member.

4. Are you under evaluation for COVID-19? For example, you are awaiting COVID-19 test results because you were a close contact of a known case, or were experiencing COVID-19 symptoms.

If YES  $\rightarrow$  Stay home and wait for test results.

★By attending in-person Rec & Ed programs, you are acknowledging that none of the above applies to you or a household/family member.

★If you are experiencing COVID-19 symptoms, contact your healthcare provider.
